Silver Valley Fuller Center Holds Elections

During the January meeting, the Board of Directors elected new officers for 2011. Mike Humphrey, Ed Vang and Verne Blalack remained as President, Vice President and Treasurer. Haiti Update

Fifteen families have been able to move out of the tent camps, away from disease and destruction, into simple, decent, solid homes. Their homes were built from the ground up with the help of donations and volunteer labor through The Fuller Center for Housing, a non-profit ministry dedicated to the elimination of poverty housing worldwide.

With 15 houses now complete--and processes and land in place--the organization's homebuilding efforts are accelerating. The Fuller Center and its partners currently have enough land in Leogane to build 100-140 houses and additional land is being acquired in a village called Balan for the construction of another 50-100 homes. Two Fuller Center volunteer teams from the United States have traveled to Haiti to help build. Another 8 teams are lined up for the first six months of 2011.

A REPORT ON OUR GREATER BLESSING ACTIVITIES

In 2010 our low income home improvement and repair program (GB) consisted of : two major bathroom makeovers (one in Wallace and one in Kellogg), one small bathroom repair job in Pinehurst, one mobile home ramp in Osburn and a shed security job in Mullan.

The resources that enabled us to do these improvements came from four sources..

- ❖ From 5% of all unrestricted cash donations.
- ❖ From all donations requested to go to that program. From some recipient repayments and from donations of labor and materials.
- ❖ \$862 came from our 5% tithe. \$226 came from donor restricted donations.
- ❖ \$134 was paid back by recipients.

Especially appreciated was the labor donated on the bathroom overhaul in Wallace and Bob Larson's donation of a lot of his labor, wages and transportation costs on the Osburn mobile home ramp.

The program was designed to be a "don't fix it if we don't already have the funds to pay for it program". However, we underestimated the cost of the Osburn ramp job and have borrowed about \$300 from the general fund to pay for the cost overrun. Therefore, we aren't initiating any more GB activities until we have more money in the GB fund.

For 2011 we hope to provide some volunteer labor and some construction advice (no money) to a family in the Kingston-Cataldo area that has ten children. They have their property and triple wide commercial manufactured building to be installed on it. We may also be working on another improvement property in the Cataldo area. If you really are in need (not just only want) of a small home improvement or repair job, let us know and maybe we can get to it in the latter half of 2011. You can pay us back as you can.
