Habitat for Humanity/Silver Valley Fuller Center for Housing - Then and Now

In 1993 my husband, Jim Shadle, and I, Lois, had just moved to Cataldo. We had been working with Habitat in Coeur d'Alene and had gone to Yakima, WA, with a group of teenagers to start building a four bedroom house for a family who needed housing.

One weekend, we went to the craft fair in Osburn, where a couple of women were showing pictures of what Habitat was doing around the world. They were recruiting people to start an affiliate in the Silver Valley. We were interested and signed up to attend a meeting in Kellogg and soon joined the group. We started on our fundraising immediately. Some of the first fundraisers were the Pig Roast and craft fairs where we sold T-shirts, cook books, and crafts. Many came on board and started working on projects to build our first house.

On August 10 the Steering Committee voted to become a Board of Directors in preparation for affiliation with Habitat for Humanity International and also elected new officers. The board chose Norma Seaton, President; Lois Shadle, Vice President; Judy Blalack, Secretary; and Verne Blalack, Treasurer. Other Directors were Betty Belisle, Christy Fulton, Clarence George, Frank Gitter, Father George King, Janet Lake, Sister Petronilla, Barbara Miller, and Jim Shadle. (*Continued on Page 2*)

DARNELL IS GOING TO WALK

By Verne Blalack On my last Avista bill I was charged \$49.42 for the first 600 kilowatts (KWs). [One therm is almost 30 kilowatts.] The equivalent amount of gas energy costs me \$18.75, that is to say, electricity costs me two and one-half (1½) times as much as natural gas for the first 600 KWs. After that, the price per KW goes up and it costs me two and three fourths (2¾) times as much.

The last time I spoke with Amie Pelham, (who lives in Mullan) she said that her recent Avista bill (for both electricity and gas) was one hundred and seventy some dollars with a significant air leak under one exterior door (which Swede has fixed by now). We will be starting to rehab a house in Smelterville soon and are strongly considering building an external insulated wall around the house like we did with Amie's. Doing this produces an R30 (9-inches) of fiberglass covered with house wrap and no maintenance vinyl siding. We stock piled at very low cost vinyl siding when a warehouse in CDA collapsed a few years ago.

We are helping Darnell Kriedeman and her son, Kyle, rehab this home. Bob Larson and Swede Little will be the regular site supervisors. Hopefully, we will be working on this home around six days a week as Kyle is going to help every day that we work. This will be a great blessing for Darnell and Kyle as the faster we get this home built; the faster they can pay off their debts and start accumulating an emergency fund. Darnell can then walk to work at Wal-Mart and avoid those high transportation costs. The other two homeowners-to-be, the Lavergne's and the Huber's, will be putting in their six hours per week sweat equity and getting valuable experience, which will be put to good use when we help them build their home.

Another major blessing for the Kriedemans is the volunteer work groups, especially the RV Builders and the Shoshone Base Camp kids, who come and help us build these affordable homes. Then, in addition to our regular site supervisors, we have to rely on our super supervisors Kevin Hutchings, Rick Gilbert and Jim Taylor and his sidekick to help us handle the larger groups. This year, we will also be hosting the "Bike Adventure!" group who will be staying at the Wallace High School. They will spend Saturday, June 18, helping.

By the time you read this, Systems Design (Jeff Crawford) may be able to get a new furnace and water heater in and lines run for a range and dryer. By then, the water and electricity will also be turned on. So..., start letting us know when you can help Darnell and Kyle get into their home. If you would like to work on a particular job, we will schedule you in and teach you how to do it. Contact us at the Blalack's 682-3240. It is possible we may be able to provide transportation to the work sites.

On October 1, 1993, we were officially accepted as a Habitat affiliate. We were on our way to building affordable housing for eligible families.

We started small, and now we are working on our 18th house--what a wonderful thing to see!

We now have a "Greater Blessings" program, which consists of helping homeowners with extremely limited income do small repairs. These homeowners are encouraged to repay our expenses as they are able so we have funds to help someone else. So far, we have completed 6 "Greater Blessings" projects. Of these, 2 have been repaid in full. ©

With (not for) families at the forefront of our mission, we are pleased that so many people have donated and volunteered to make ours a growing community of affordable housing. Many of these donors belong to our "300 Club" where they pledge to send at least \$10/month or \$120/year. We mention these donations (unless they wish to remain anonymous) in the newsletter, but we do not mail a separate thank you.






The <u>newsletter ads</u> pay most of our monthly mailing costs. Many of our <u>"Cash Donations"</u> come back through the envelopes we include in those we mail. However, more cash donations are via direct bank payments, saving the donors the cost of mailing. Many of these donors receive the newsletter via email (in color).

Let us know if you want yours via email.

<u>GIK</u> means "Gift in Kind" material donations.

<u>Sales</u> include GIK and items such as shirts.

We received <u>grants</u> from US Bancorp and Inland Northwest Combined Federal Campaign.



Administrative costs are kept as low as possible. These do include our board insurance—required now. All our office workers are volunteers. The only paid people are construction supervisors and their wages (pretty low) are charged to the individual construction sites.

Education includes training for construction and part of the newsletter expense. The 990-taxes puts it there because of its role in keeping our public informed.

<u>Inventory</u> costs include gas for gleaning and transporting to the Hayden Re-Store.

<u>Sales tax</u> is figured each January for the previous year on our events like Bike the Wall. We are *not tax-exempt* for items we purchase such as office supplies or construction materials.

<u>Fund raising</u> costs include new equipment such as awnings that seem to only last one year (if we are lucky). They also include the cost of meat for the Pig Roast, shirts & BBQ for the "Ride the Wall", etc., and insurance for the events.

<u>Other construction</u> includes the donations we sent on for Haiti homes, our tithe to the Fuller Center for Housing to be used in 3rd world countries for materials only, and for our Greater Blessings projects in our Valley.

Local home construction naturally gets the lion's share of our \$. We finished and dedicated 2 homes in 2010!

We do try to be good stewards of your donations in both money, and labor. Thank you!
