#### 2009 Economics

This year it has been a challenge for me, Judy, to give you an understandable presentation. We had become independent from Habitat International and changed our status again when we joined the Fuller Center. For future easier bookkeeping, we also switched from a fiscal year ending June 30 to a calendar year.

[I'm glad to be able get enlightenment from our Treasurer/Bookkeeper, my patient hubby, Verne.] We began the year with a healthy bank balance since several homeowners paid off their mortgages in 2008. Our expenses exceeded our revenue due to several factors:

We had less in monthly mortgage payments since we held fewer mortgages.


We continued to work on construction on more than one site.

We spent funds on the "Little Shop" which will not show a profit until we have sold all the raffle tickets.

We spent more on insurance than in the past since we had to buy insurance as an independent entity.

We received fewer grants since we were waiting for the IRS's final proof of independence from Habitat before training our new grant writer

Although we have kept a wide base of faithful donors, the lower economy has hurt non-profit fund raising.



During the year we accrued \$27,000 from donations, grants, and fund raising. We also received \$23,000 (after withholding taxes and insurance) in mortgage payments thus our cash intake was \$50,000.

We spent about \$71,000. Of that, 8% was for insurance—for site, administration & fund raising events. Adding on the cost of administration insurances of \$1597, our administrative overhead is less than 4%. The Fuller Center has a new group insurance agreement, so we expect this cost to drop!

So, although we spent more than we received in 2009, we still had a nice balance left of about \$50,000—enough to finish houses #16 & 17.

Construction costs have jumped since we began in 1994. The highest percentage increase is in permits and fees (240% - from \$5000 to \$12,000) during the last 5 years. The last few years we have needed to hire part time construction supervisors, Bob and Kevin. Although Jim Taylor and Rick Gilbert do donate some time, they cannot afford to be full-time volunteers, so we do also occasionally hire them. Another occasional expense is for some gas—added for obvious reasons.

Our **tithe** on undesignated income is split—10% goes to the Fuller Center for Housing to be spent on materials for homes in 3<sup>rd</sup> world countries and 5% is collected to be spent on Greater Blessings projects here in the valley.

Greater Blessings Program is a new venture of Silver Valley Fuller Center. Homeowners can apply for small repairs. A supervisor will assess the project to see if it is something we can handle with our labor and monetary resources. When the project is complete, the homeowner receives a "Greater Blessings Box" with some return envelopes in it to make restitution for our expenses when they can afford it. We have begun receiving donations designated for these projects in addition to our 5% tithe. We also received over half the cost of one project back from the homeowner. These monies with be recycled into the next project.

Money spent in our home construction in the Valley is considered an asset since we will be selling them at no-interest mortgages to the new homeowners. As noted above, the mortgage payments are recycled into new homes.

We are looking forward to an eventful 2010 with several Greater Blessings projects (as many as \$ and volunteers will support). We will finish the Lake home this spring, the Pelham home this summer, and start the Kriedeman home in June.

This year, we have also been accepting donations for long-term Haitian relief toward the construction of small \$3000 earthquake proof homes. So far, we have collected \$4240 and have another \$1000 pledged.

We thank these businesses for supporting our newsletter.
