Patience Paying Off

It's been a long time coming, but Brian Canterbury is seeing a light at the end of the tunnel.

Brian is the latest recipient of efforts by Silver Valley Fuller Center for Housing to provide a home for those who likely would not have otherwise been able to fulfill that dream.

His journey to this stage in his life began Sept. 19, 2002, when he suffered a stroke at a young age. It left him with limitations in his right arm and hand, right foot and eyesight plus some brain damage for which he will continue receiving treatment and medication the rest of his life. He was hospitalized for 29 days.

"I couldn't do anything on my own when I had my stroke," he noted.

But with a goal of self-independence, he has gradually regained many abilities to where he can sometimes help his parents with their home. He has been living with his parents since he was released from the hospital.

"It's been a long time since I lived on my own, a real long time," he said. "Thanks to my Lord and Savior Jesus, I can do what I can."

He has learned to adapt and has come a long way. He has been working with John Boy Delaney on preparing the grounds around the house Fuller Center has obtained for him and plans to help out when work begins inside as well. The house is a mobile home on a lot in Osburn which he is hoping will soon be his.

Brian has been on the Fuller Center list for a home for several years. His physical limitations have also limited his income level. And he said moving into a group home is not an acceptable alternative.

So, he continues to work with Fuller Center and now has hope that his efforts will be coming to fruition.

This shed behind the mobile home was crammed full of unusable items after snow had collapsed the roof. The shed has been dismantled and it and all the stuff inside have been hauled away.



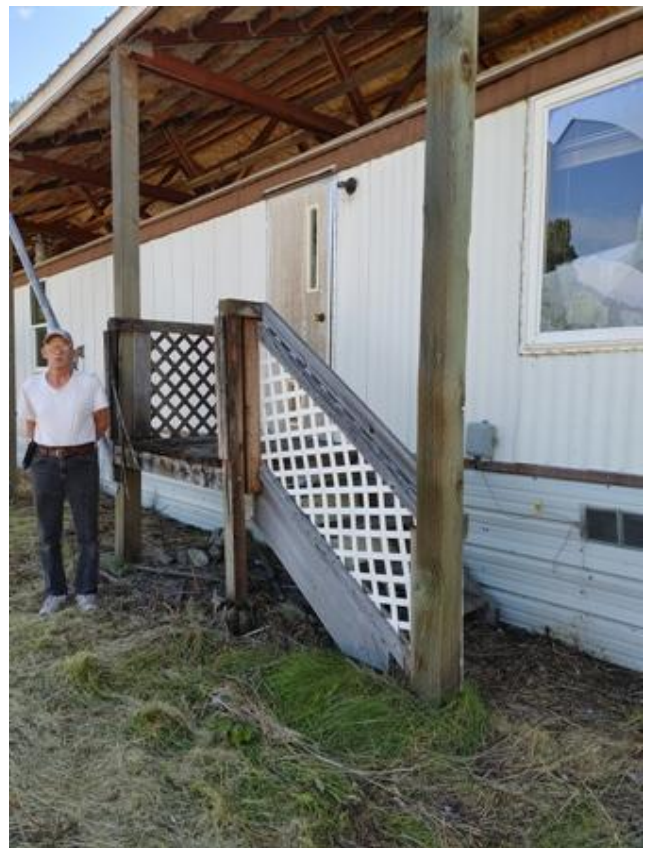
