Brian's Trailer Update

I can't say enough positive things about this group of electricians. Joshua with the Ma'Or foundation first called me in June after searching The Fuller Center's main website and finding our location – the closest to them from Seattle. I explained our situation with the main focus on this trailer and the first project was fixing the floors. After several communications with president, Bob Whitman, and having a relative take a video, the Braunstein family made the trip. Upon arrival, they collected the plywood and made a tremendous amount of progress removing and reconstructing severely damaged items including:

- removed and replaced the subflooring throughout
- drained and removed the rusted hot water tank
- removed sinks, cabinet, and toilet in bathroom
- installed new vinyl plank flooring in the bathroom
- removed rotted closets
- primed walls in various locations
- removed cabinet doors and stove in kitchen
- various other cleanup tasks

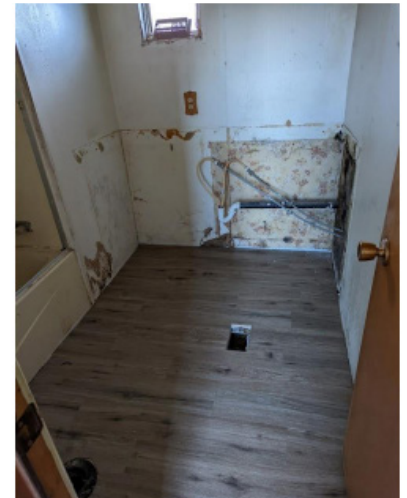

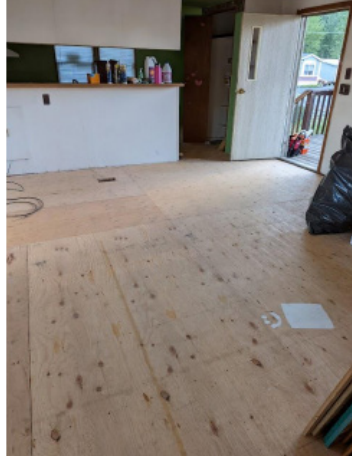

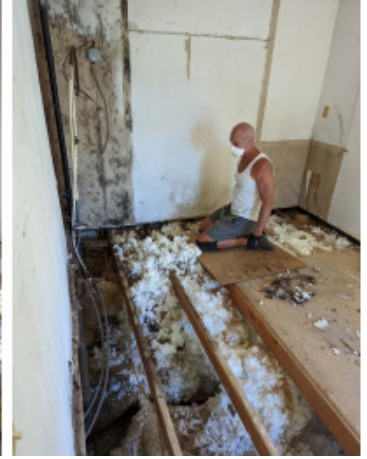
